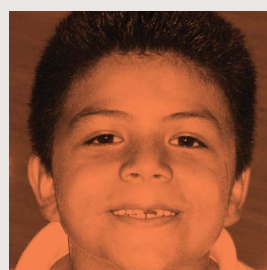

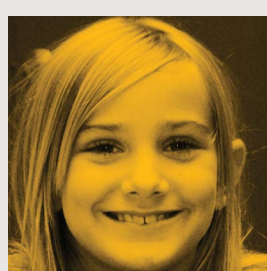

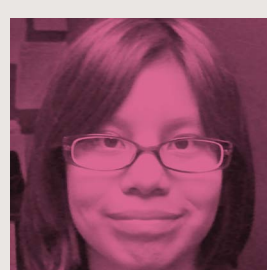
BE GREAT, DO GOOD *Michael, age 16*

DEAR FRIENDS,


