3. File completed form with your Arizona State Tax return. It's That Easy!

Not Sure How it Works? - Here's answers to FAQ's

What is a tax credit?

A tax credit reduces your tax liability dollar-for-dollar. In other words, a tax credit comes right off the top of your state tax bill, lowering the amount you will pay or increasing your refund.

How do I qualify?

1. You must itemize charitable contributions on your tax return.
2. You must establish a baseline year for charitable contributions
3. Make a donation to the Boys & Girls Clubs of Metropolitan Phoenix, a Qualified Charitable Organization Helping the Working Poor that exceeds charitable contributions in your baseline year is your tax credit.

When is my baseline year?

Your baseline year is the first year – as early as 1996 – that you itemized charitable deductions on your federal tax return. Once established, your baseline year does not change unless you change your filing status.

If I didn't donate last year, can I still get a tax credit this year?

Yes, once your baseline year has been established, you become eligible for the tax credit the following year and any future years.



Does this tax credit affect the private and public schools tax credits?

No, you can receive a dollar-for-dollar tax credit for giving to this program as well as any of three tax credit programs!

Do I have to give \$400 to get the tax credit?

You may receive an Arizona state tax credit of up to \$400 if you are married and filing jointly, or \$200 if you are married and filing separately or a single taxpayer or head of household. But, any amount less than \$400 (married) \$200 (single) still qualifies!

How does this tax credit impact my ability to take a federal tax deduction?

Your contribution can also be included as a deduction on your federal tax return, reducing your taxable income, maybe even resulting in decreased Federal taxes!

Can I take the tax credit if I don't owe any money to the State when I file my taxes?

Yes! The tax credit reduces your tax liability and will serve to increase your tax refund if you have paid in more taxes than you owe.

How do I document my contribution?

We send you a contribution confirmation letter that documents your donation.

How do I file for the credit?

You or your accountant will complete AZ Form 321, a simple tax form. The form is included with materials provided by the State of Arizona to all state tax filers.
